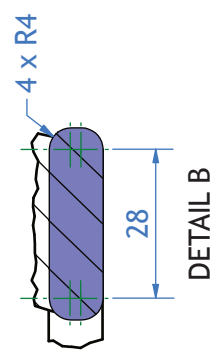

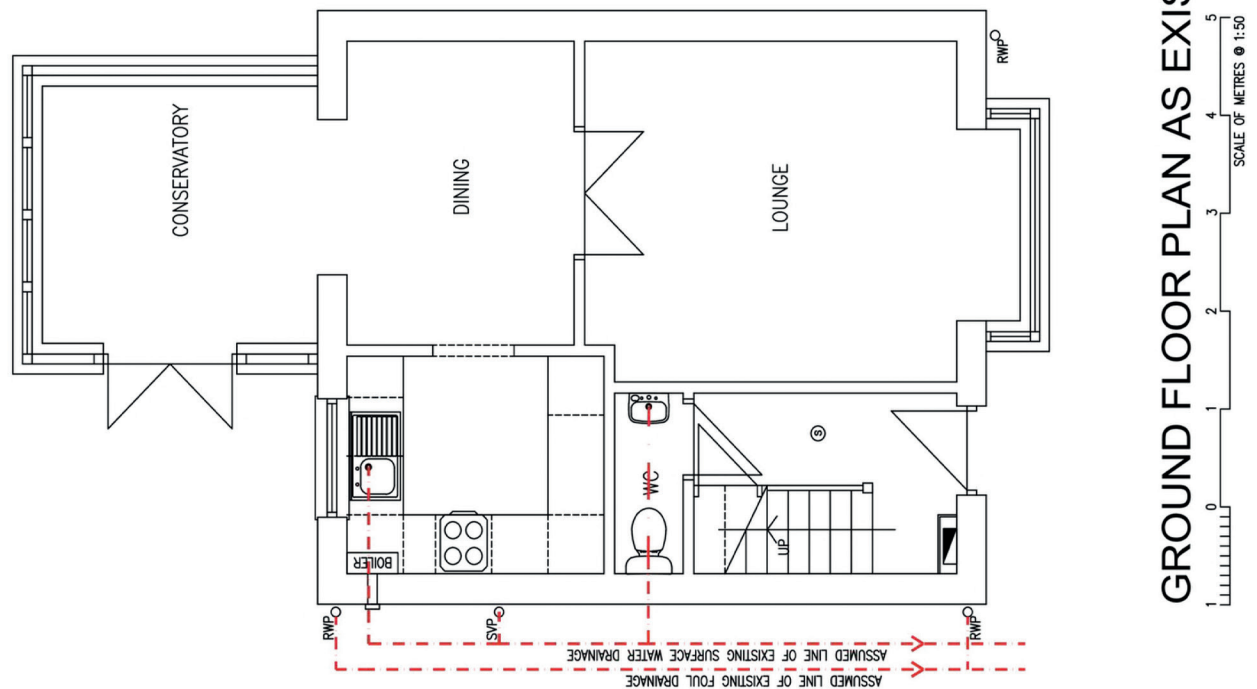

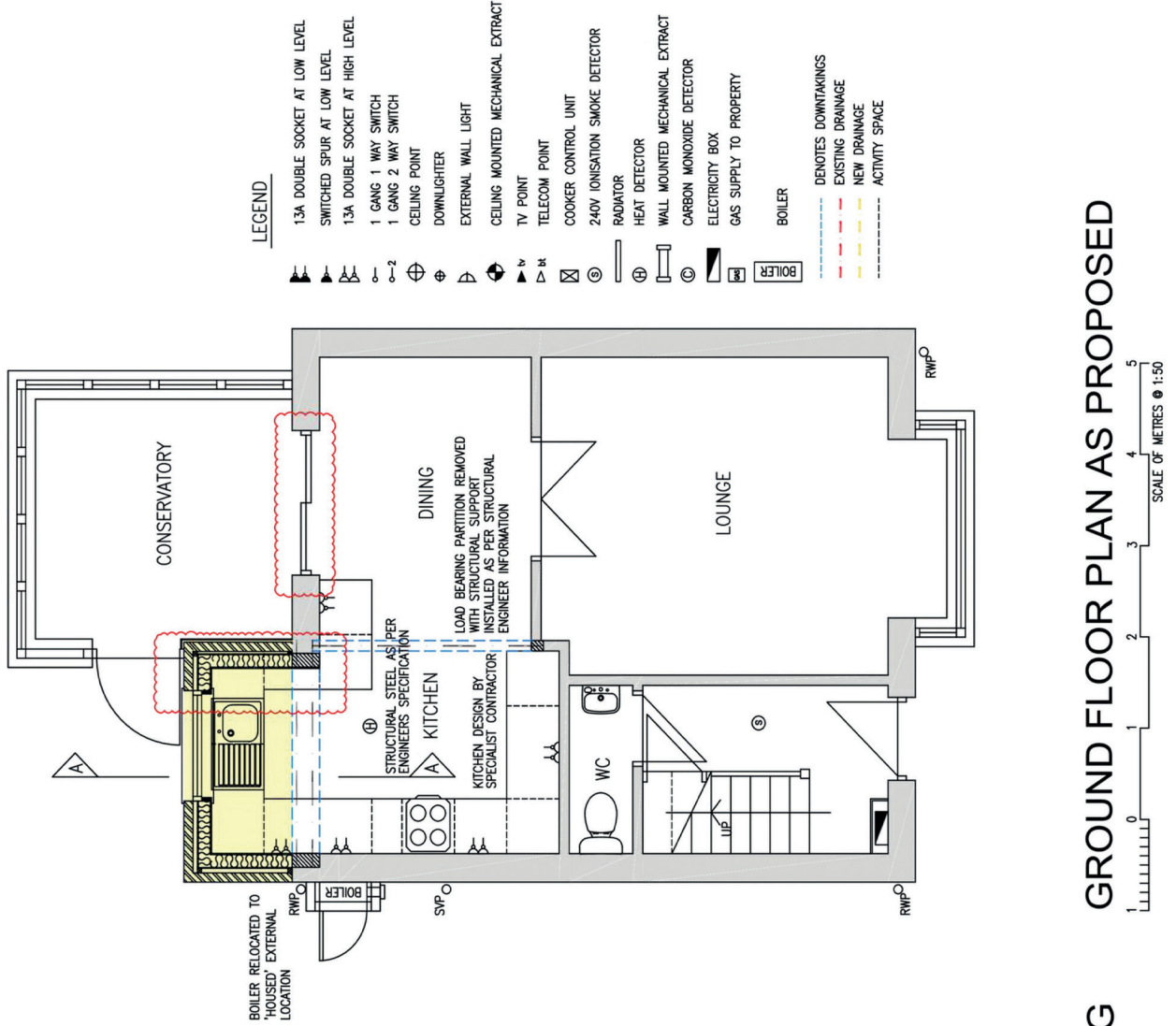

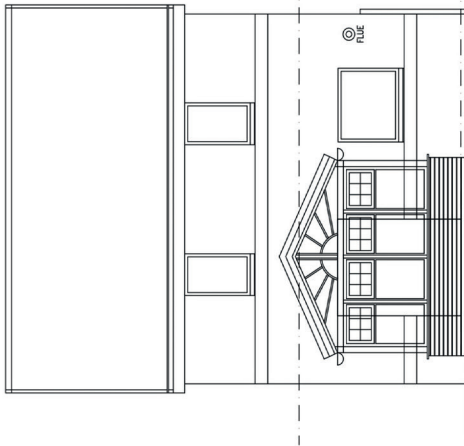
GROUND FLOOR PLAN AS EXISTING



GROUND FLOOR PLAN AS PROPOSED

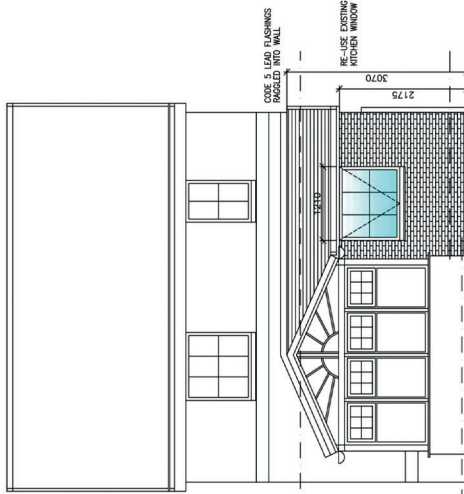

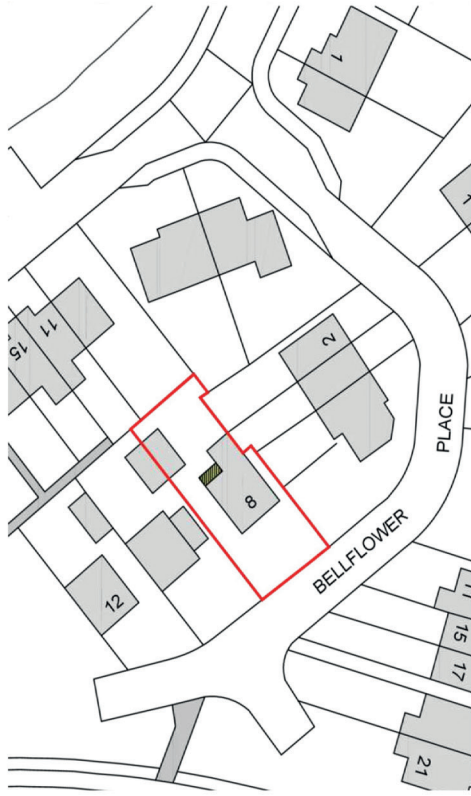
REAR ELEVATION AS EXISTING

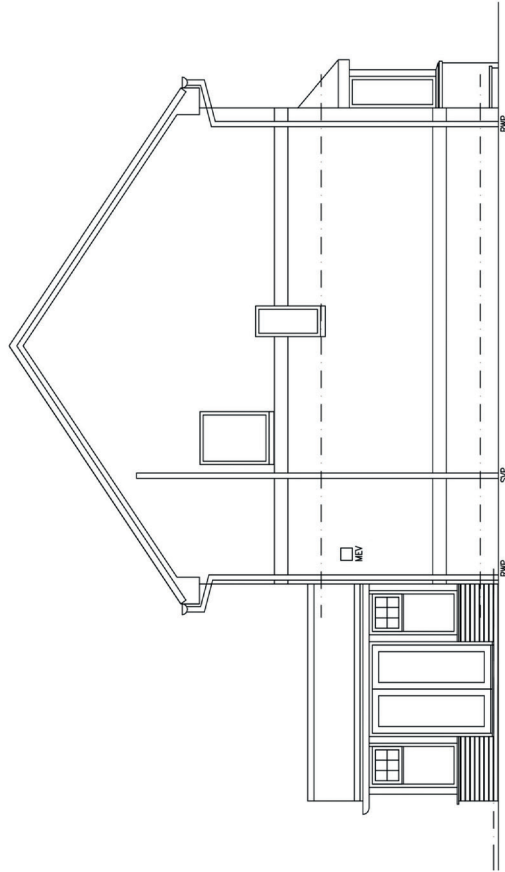


REAR ELEVATION AS PROPOSED

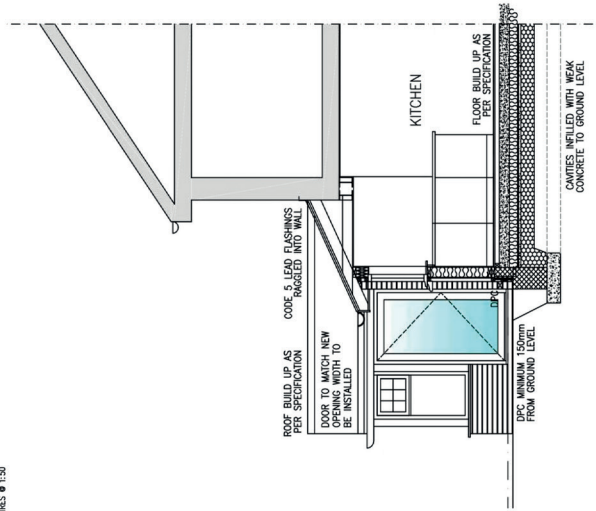


LOCATION PLAN AS PROPOSED
